1. Privacy policy

2. Refund Return policy

By California and Federal law, we are unable to accept returns of alcoholic beverages unless the product is corked/flawed or it was purchased in error. Fenestra Wines will replace free of charge or refund the purchase price any wine that is flawed or otherwise deemed unacceptable for consumption upon receipt of the wine in question.

We will replace wine that was ordered in error and will offer refunds upon receipt of the unopened wine in question. California and Federal law do not allow returns if the customer does not like the product or bought too much.

3. Terms and conditions

By using this website ("fenestrawinery.com"), you, the customer, agree to all of the terms and conditions expressed in these Terms of Service. This constitutes an enforceable and binding agreement between you and Fenestra Winery. You agree to use this website only for the purposes listed in these Terms of Services, including for purchasing Products or any other products which may be offered through this website from time to time.

4. Secure Check out
